BY-LAW NO. 1567

**A bylaw to convert Denman Island
Water Service Specified Area No. 3 Local Service Area**

WHEREAS under Section 767(4) of the Municipal Act, a regional district exercising a power to provide a service other than a general service, may adopt a bylaw respecting that service which converts the service to one exercised under the authority of a bylaw establishing the service and which:

- i. meets the requirement of Section 794 for an establishing bylaw; and
- ii. is adopted in accordance with the requirements of Section 802 as if it were a bylaw amending an establishing bylaw;

AND WHEREAS the Regional District of Comox-Strathcona adopted Bylaw No. 97 being "Denman Island Water Service Specified Area No. 3 Establishment Bylaw, 1972" on the 26th day of February, 1973 which created Water Service Area No. 3 located on Denman Island;

AND WHEREAS the Regional Board wishes to convert the aforesaid Water Service Specified Area No. 3 such Service Area to include a portion of Electoral Area A;

NOW THEREFORE the Regional Board of the Regional District of Comox-Strathcona in open meeting assembled, enacts as follows:

Service

1. The area created under Bylaw No. 97 being "Water Service Specified Area No. 3 Establishment Bylaw, 1972" is hereby established as a Local Service Area.

Boundaries

2. The boundaries of the Service Area shall be the defined portion of Electoral Areas A as described on the attached Schedule A which forms part of this Bylaw and shall be known as the Denman Island Water Local Service Area.

Maximum requisition

3. The maximum amount that may be requisitioned annually for the cost of the service established by this bylaw is \$6250.

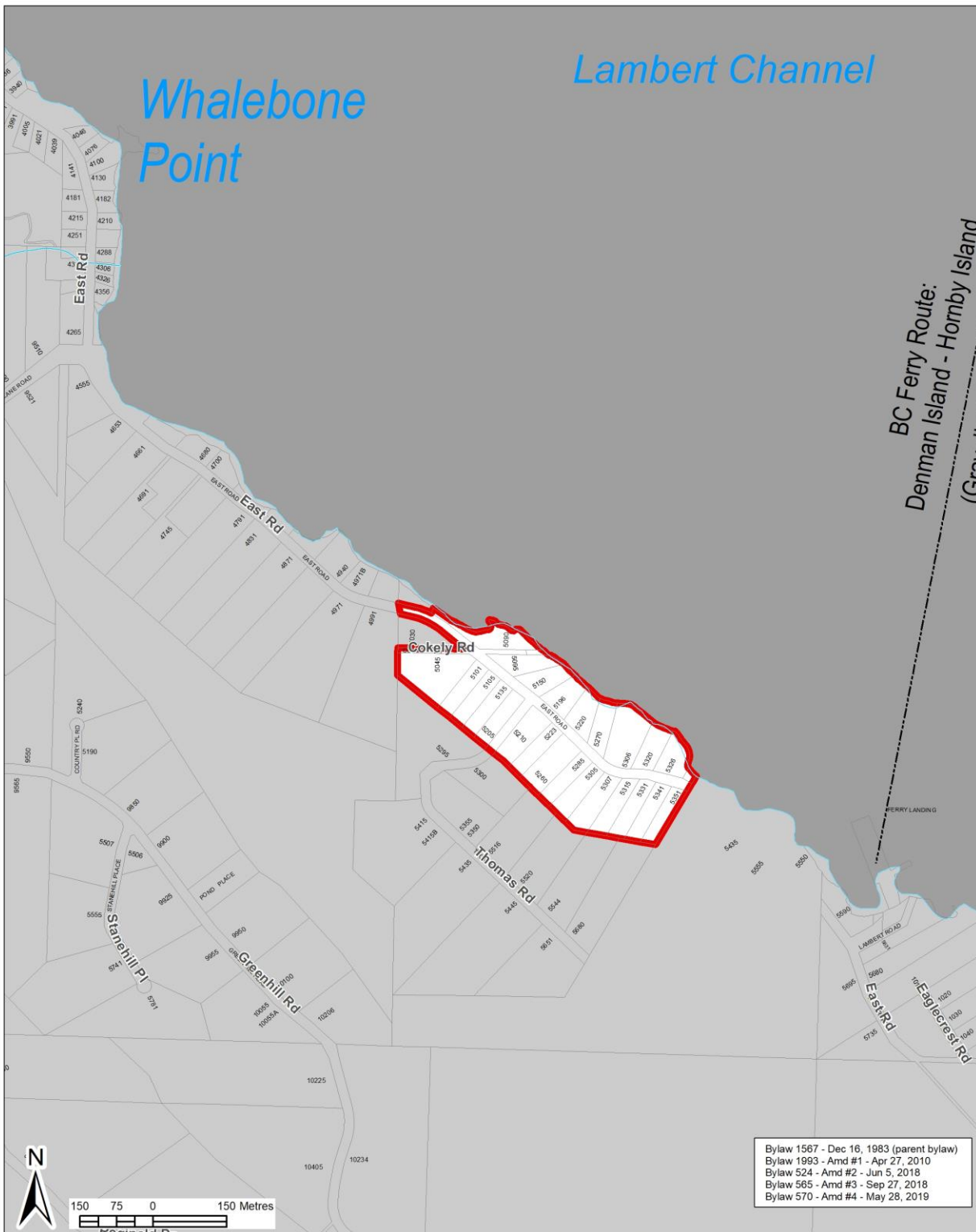
Cost recovery

4. The annual cost of providing the service shall be recovered by one or more of the following:
 - (a) Property value taxes;
 - (b) Parcel taxes;
 - (c) Fees and charges
