Bylaw No. 851 being "Comox Valley Homelessness Supports Service Establishment Bylaw No. 389, 2015, Amendment No. 1"

- Postmarks will not be accepted as the date of receipt by the CVRD.
- Elector response forms being submitted electronically via email must be submitted as either a scanned copy or a photo of an original signed form.
- Accurate copies of this Elector Response Form may be made and used for signing.
- A person may not sign more than one Elector Response Form.
- The Board may proceed with the adoption of Bylaw No. 851 being "Comox Valley Homelessness Supports Service Establishment Bylaw No. 389, 2015, Amendment No. 1" unless 4,701 electors sign and submit a completed elector response form by the deadline.

Bylaw No. 851 Synopsis

The purpose of Bylaw No. 851 is to authorize the Comox Valley Regional District (CVRD) to increase the maximum annual allowable requisition for the Comox Valley Homelessness Supports Service to the greater of \$550,000 or \$0.02732 per \$1,000 of assessed value. Bylaw No. 851, if adopted, would enable the CVRD Board to consider the provision of increased grants to community-based organizations to address homelessness in the Comox Valley.

The service area applies to the municipalities of the City of Courtenay and Village of Cumberland as well as the electoral areas of Area B (Lazo North), Area C (Puntledge - Black Creek) and a portion of Electoral Area A (Baynes Sound – Denman/Hornby Islands).

Elector Eligibility Requirements

Resident elector (section 65 of the Local Government Act)

- be 18 years of age or older;
- be a Canadian citizen;
- have been a resident of British Columbia for at least six months;
- be a resident of the jurisdiction (e.g., municipality or electoral area);
- live in the area defined for the AAP; and,
- not be disqualified under the Local Government Act, or any other enactment from voting in a local election or be otherwise disqualified by law.

Non-resident property electors (section 66 of the Local Government Act)

- 18 years of age or older;
- a Canadian citizen;
- a resident of British Columbia for at least six months immediately before signing this form;
- not entitled to vote as a resident elector in the area defined for the AAP;
- a registered owner of real property in the area defined for the AAP for at least 30 days before signing this form;
- not be disqualified from voting under the Local Government Act or any other enactment or otherwise disqualified by law from voting.

Additional notes for non-resident property elector(s): Only one non-resident property elector may sign an elector response form per property, regardless of how many people own the property; and, that owner must have the written consent of a majority of the other property owner(s) to sign the response form on their behalf. Property owned in whole or in part by a corporation does not qualify under the non-resident property elector provisions.
