The Maris Nature Park is currently an undeveloped piece of land that was gifted to the regional district through the federal government's ecological gifts program. The intent is to activate the space by having a few trails pass through the existing forest area and provide more clear beach access but to otherwise leave the majority of the land natural and passive.

There is no signage for the space. There are various residents in the area and users are aware that there are routes that lead to waterfront or beach type property, however, the Maris Nature Park is currently undeveloped and unmaintained. It is recommended that the regional district consider implementing signage communicating:

- No unauthorized Access
- Unmaintained Natural Area
- Downed Trees, Uneven Footing, Wildlife Present
- Areas that there is a potential fall from height
- Directional indicators that assist users to navigate to a sanctioned/developed pathway for use
- Emergency Contact Number
- Regional District Contact Number to report maintenance issue or incident

There are roadways owned by MOTI that provide access either directly to the Maris Nature Park space or adjacent greenways, trails that allow access to the Maris Nature Park and are used by the public.
